### **Ordinary Resolution**

To be passed an Ordinary Resolution must receive votes from a simple majority (i.e., 50% plus 1) of those members who being eligible to do so vote in person on the ordinary resolution at the meeting

### **Under the Registered Clubs Act**

- Members who are employees of the club are not entitled to vote and
- Proxy voting on this resolution is prohibited

The board of the club recommends the following Resolution to members

### **Ordinary Resolution**

That pursuant to the Registered Clubs Act:

- The members hereby approve expenditure by the club in the sum not exceeding \$10,000 over the following twelve months for the following activities of Directors
  1. The cost of meals and beverages for each Director immediately before or after a Board or Committee Meeting, on the day of the Meeting.
  2. Reasonable expenses incurred by Directors in travelling before or immediately after a Board or Committee Meeting as approved by the Board from time to time on production of invoices, receipts, or other proper documentary evidence of such expenditure.
  3. Reasonable expenses incurred by Directors in relation to such other duties, including entertainment of special guests of the Club and other promotional activities as is performed as a director in relation to the Club which expense are approved by the board before payment is made on production of invoice, receipts, or other proper documentary evidence of such expenditure.
  4. The reasonable cost of Directors attending seminars, lectures, trade displays, training and other similar events as may be determined by the board from time to time.
  5. The reasonable cost of Directors attending other clubs for the purpose of observing their facilities and methods of operation.
  6. That the members hereby approve expenditure by the club in a sum not exceeding \$1,000 for the purpose of providing each Director with a uniform
